

Consolidated Appropriations Act of 2021



FAFSA

The **FUTURE Act** allows the IRS to share data with FSA for increased ease in administering federal student aid programs.

The **FAFSA Simplification Act** introduces significant changes to the FAFSA application process including changes to the FAFSA form, how students and families will complete the application and the eligibility calculation.

- Full implementation for 2024/25 Academic Year (AY)
- Overall, less questions due to planned seamless exchange with IRS. Lowest income families have the fewest questions to answer.

What's NEW in Financial Aid

FAFSA Simplification: 2023-24 FAFSA[®] changes:

- Selective Service and Drug Conviction questions have been removed from the FAFSA.
- The homeless youth questions will be prefilled for renewal applicants.
- Voluntary Survey added to electronic FAFSA- applicants will be asked their gender, whether they are transgender, their race, and their ethnicity.
- Pell Grant eligibility for confined or incarcerated students enrolled in an “eligible prison education program”.
- The myStudentAid Mobile App was retired on July 10, 2022. Users will still be able to complete their FAFSA application on a mobile device by navigating to StudentAid.gov on their mobile browser.



- Students should know that the Free Application for Federal Student Aid (FAFSA[®]) is a federal application used to determine student eligibility for:
 - Federal programs
 - State programs
 - School programs



Types of Financial Aid

Pennsylvania Association for College Admission Counseling



Grants: Free Money (based on financial need)



Scholarships: Free Money (based on merit/select criteria or need)



Work Study: Earned Income



Student Loans: Borrowed money that must be repaid



Additional sources: 529 plans, tuition payment plans, savings, etc.



Filing the FAFSA®

- Students must file a FAFSA® every AY (academic year) they are enrolled
- Available October 1st
- Deadlines Exist!
 - Federal (end of AY)
 - PA State Grant (May 1st or Aug. 1)
 - School (vary based on school)
- Apply online at: studentaid.gov or fafsa.gov

The FAFSA is broken down into seven sections

■ **Student Demographics:**

- Legal name as it appears on SS card
- Social Security # or alien registration #
- Permanent address
- Email address (use one that you will check often)

■ **School Selection :**

- Must choose at least 1 school
- Indicate if living on/off campus or with parents
- Only schools listed will receive results of FAFSA
- Update PA State Grant with final school choice
- Don't have to be accepted or have applied to list school on FAFSA

- **Dependency Status:** helps to determine if parent's information is required

Dependency Status

Independent Students are:

- 24 or older on Jan 1st of award year
- Veteran (includes active-duty personnel)
- Working on graduate degree
- Emancipated minor in legal guardianship
- Orphan, in foster care, or ward of the court at anytime when student was age 13 or older
- Have legal dependents other than spouse
- Student deemed homeless by proper authority

- Unearned income not reported on taxes
- Balance of checking/savings account
- Value of assets (stocks, bonds, college savings plans, etc.)

■ Sign(student & 1 parent) & Submit:

- Every student must sign the FAFSA
- 1 Parent must sign the FAFSA
- Use Federal Student Aid Account to electronically sign

Special Circumstances If things change....



- Divorced or separated parents
 - Recent death or disability
 - Reduced income
 - Unemployment
 - Medical or dental expenses not covered by insurance
 - Non-recurring Income or Expenses
 - Financial Hardship due to COVID-19
- ✓ Only a school can change a FAFSA related to circumstances
 - ✓ Decisions are final and cannot be appealed to U.S. Department of Education
 - ✓ Contact PHEAA for PA State Grant re-consideration



PA State Grant form (SGF)

- In addition to the FAFSA, first-time applicants must also complete the SGF.

 - The link from FAFSA confirmation page

How Can Counselors Assist?

Identify students with special circumstances: (homelessness, foster care, undocumented students)

- **Students with special circumstances:**
 - Sometimes hard to identify (stigma, fear, etc.)
 - Have trouble completing admission & financial aid paperwork
 - Requires permanent address: FAFSA, PA State Grant & college apps
 - Confusing definitions: foster care, ward of the court & homelessness, Expected Family Contribution, etc.
 - Difficulty acquiring/securing required documentation
- **Adequate School Support & Resources?**
 - Student to counselor ratio
 - Unavailable resources
 - Access to information

- Awarded to eligible PA residents who demonstrate financial need
- Must attend an approved post-secondary school
- Program of study must be at least 2 years







Do's and Don'ts



- Do:
 - Support FAFSA completion for **all** students who are intending on two, four, trade or technical school attendance.
 - Attend the annual educator workshops to learn the updates.
 - Create a BPAMS account to track FAFSA completion for families in your District. Follow up on incompletes or those flagged for verification.
- Don't:
 - Make assumptions about who will qualify or the value of completion.
 - Provide bad information just because you are asked something beyond your knowledge base.

- Questions can be sent to highschoolaccess@pheaa.org
- Once processed, the Authoritative Source (AS) will be sent a secure email from PHEAA with a username and temporary password
- The AS must access the Business Partner and Access Management System (aessuccess.org/apps/bpams.nsf/home) to change password and grant access to view reports
- Schools access their FAFSA reports via PageCenter through PHEAA.org


